### 1. <u>SECTION 'A' – ITEMS FOR INFORMATION</u>

#### (a) Aber Valley Community Council – Budget

A copy of the income and expenditure from April 1<sup>st</sup> 2015 to date, including a balance sheet, is available for Members to examine.

#### (b) Precept

Caerphilly County Borough Council has transferred the first instalment of the 2015/16 Precept into the Community Council's bank account - £14,750.

#### (c) <u>Telephone Account – Community Council Office</u>

An invoice has been received from British Telecom for £73.22 (including VAT). This payment is made by direct debit.
