114/2014 POLICE MATTERS

Inspector Gareth Jones and P.C.S.O. Ian Williams of Gwent Police attended the meeting and reported on the following matters:

- (a) Inspector Gareth Jones updated Members on the new working arrangement for Gwent Police.
- (b) Drug crime is a problem in the Aber Valley a number of warrants have been issued.
- (c) Inspector Gareth Jones conveyed thanks for the intelligence received from the community.
- (d) P.C.S.O. Ian Williams has visited the residents at Caerlwyn Farm, Abertridwr. Illicit tipping is being monitored P.C.S.O. Ian Williams to arrange for signage to be put in place.
- (e) Ticket figures for August 2015: 21+ for the Caerphilly area. Most offences in the Aber Valley were at High Street and Brook Street, Abertridwr.
