166 Apologies

167 Declarations of Interest

Cllr Louise Stephen declared an interest in min no.178 Cllr Dave Rees declared an interest in min no.178

168 Mayors's Announcement

Cllr Hazel Dupre wished everyone a happy new year and thanked the Clerk and Members for helping out at the pantomime, which had been a great success. She also thanked Cllr Brian Hancock, the Clerk and Cllr Nigel George from East for distributing the remaining selection boxes to the food banks at the Salvation Army, local Churches, Brookland Resource Centre, Twyn Carn Day Centre and Barnardos.

Cont'd Mayor's Announcement

Cllr Hazel Dupre attended:

- Meeting at Ty Penallta whereby the Crime Commissioner gave an informative presentation.
- Risca Food bank based at the Salvation Army, which is a highly organized project where people in need can exchange vouchers for a selection of food to provide meals for 2/.3 days. However there is a limit of 3 vouchers per family. Access to other professional services and advice is also available to people.
- Risca Primary School Council whereby the Mayor spoke about similarities and differences between School and Community Councils. Children are given a sum of money and have to decide on projects and budget their finances accordingly.
- Ty Isaf Infant School Council. The children discussed projects and how they consult with children throughout the school for new initiatives.
- Risca Town has been approached by Risca West Community Council to undertake a joint event to commemorate the Great War. This can be discussed at our next joint meeting.

The minutes of the meeting held on 10/12/2013 were confirmed and signed as a correct record.

170 Matters Arising

In relation to Minute No.154 Cllr Hazel Dupre insisted that she had not said that she would be conducting weekly surgeries but was certainly interested in being more proactive and possibly holding surgeries.

Cllr Dave Rees explained that he and Cllr Phyllis Griffiths drop off 200 leaflets at local peoples homes on a Sunday. People have the option to display the leaflet in the window indicating that thy wish to speak with their local ward member. From experience this was a more effective way of speaking with the public and also in reaching some of the most vulnerable in our society. Cllr Dave Rees suggested that Town Councillors maybe want to consider accompanying the Ward Members.

It was noted that Pact meetings are not working as well as they should. It was felt that this was due to the lack of qualified Police Officers attendance. The Crime Commissioner is looking to make them more engaging and meaningful.

In relation to Minute No. 164 Cllr Stephen Tom indicated that he had not received a response from the Inspector in relation to traffic calming measures at the bottom of Pontymister. The Clerk requested Cllr Tom forward the report/email to herself and she in turn would write to the Commissioner.
