29/2022 APOLOGIES FOR ABSENCE

There were no public matters.

32/2022 POLICE MATTERS

There was no representative of Gwent Police in attendance.

The Police report from C.S.O M. Kerswell which was circulated to members, prior to the meeting, was noted.

33/2022 <u>COMMUNITY SAFETY WARDEN – CAERPHILLY COUNTY BOROUGH</u> COUNCIL

The Community Safety Warden (CSW), Margaret Reed, advised members that 412 visits had been made to the Aber Valley area since September 2021. There had been 2 ASBO referrals made by the CSW, and 80 persons had been spoken to. Advice has been given to persons in the Aber Valley area in relation to antisocial behaviour and litter and specific patrol areas are recognised. General

enquiries and issues are dealt with by the CSW and are referred to the relevant department in Caerphilly County Borough Council, which can also include potholes in the road and faulty street lighting.

Reference was made to the restrictions on sports pitches in relation to dogs and the requirement for dog walkers to carry dog bags. The CSW advised members of the Caerphilly County Borough Council policy in relation to sports pitches. Members discussed the possibility of providing free dog bags in some local shops. It was agreed for this item to be put on the agenda for the next meeting.
