164/2025 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors D. Berry, D. Bishop, J. Roberts, M. Stretch, and Youth Ambassador R. Mantle.

165/2025 <u>DECLARATIONS OF INTEREST</u>

Councillors and Officers were reminded of their personal responsibility to declare any personal and/or prejudicial interests(s) in respect of any item of business on this Agenda in accordance with the Local Government Act 2000, the Council's Constitution, and the Code of Conduct for both Councillors, Officers, and Clerk.

166/2025 TO APPOINT A VICE CHAIR FOR THE ENSUING YEAR

Members discussed and agreed to appoint Community Councillor D. Chamberlain as Vice Chair for the ensuing year.

167/2025 RESIGNATION OF COMMUNITY COUNCILLOR

Members noted the resignation of Community Councillor R. Gater and were advised that a 'Notice of Vacancy' was being advertised for the relevant time period until 1st December 2025. Members would be kept informed, following this deadline.

168/2025 PUBLIC MATTERS

Wayne from Draigwen Honey, attended the meeting and provided information on the bee farm based in Senghenydd and also operating throughout South Wales, including Cardiff University, situated on the roof. Information was also provided on school visits, looking at pollination and using bees honey to make candles. Members discussed a proposal to keep a small apiary (approx. 10 beehives) in the Senghenydd area on a safe, secure site for school children to be able to visit during the summer. This would increase pollination in the area and would start fostering/husbandry within the community. It was also proposed that Wayne would manage the site and the supply of honey, some of which could be available to schools/raffles, etc.

It was agreed that Wayne would provide a list of costs to Cllr. C. Bishop, who would make further enquiries and refer this item back to the Green Plan at their next meeting.

169/2025 POLICE MATTERS

Gwent Police attended the meeting and provided the following information to the Community Council, which covered October/ November 2025:

Total 72

Breakdown of some of the reported crimes.

Recent reports of criminal damage caused to cars in Abertridwr over the previous week. Unsure if all incidents are connected, however damage caused to cars did span over the course of a few hours. A diary car appointment has been booked in for the victim, and he will be providing a statement to the Constable.

There was a report of a car parked outside the street and had been smashed up. Both front and rear doors had been smashed and the rear windscreen. Currently subject is unknown. This is being dealt with via a diary car appointment with officers.

Car failing to stop – A car has failed to stop along the High Street towards Caerphilly. Caller became aware of a white car driving towards him and then pulled over to the left. A car then hit the callers' car to the rear drivers' side wheel. A red car was spotted and did not stop.

There were threats of violence at a rugby match where a small scuffle took placethis was caused by one of the parents of the players. This nearly escalated onto the pitch. Parents are made very well aware not to step foot onto the pitch. Police had attended and statements taken- investigation is ongoing.

Recorded Anti-social behaviour incidents

There has been ongoing neighbourhood issues in Bryn Aber between two neighbours. PCSO 525 has attended to which the reporting person does not wish to make a formal complaint. Safety advice was given and PCSO 525 will meet with United Welsh on a joint visit to try and long-term problem solve.

Ongoing issues regarding parking issues in the area- PCSO 525 attended, however this remained a civil matter as it was not enforceable by Police. Both parties agreed to leave each other alone during this time.

Targeted Activity

The Old Bingo Hall is being patrolled for reports of fires continuously- Side gate is open and not secure- security company made aware.

Ongoing parking issues continue- this will be looked at closer moving forward. Parking wardens from the council have been made aware.

PCSO525 will continue further foot patrols in area and speak to local businesses and residents in the area moving forward.

PCSO 525 will try to arrange the GO- SAFE van in future to raise awareness with speeding offences and take positive action.

Gaming van to be placed in the near future to reduce ASB - currently out of action until December 2025.

Continued Police surgeries to be arranged in the area-library and The Oasis.

School patrols continued during after school times due to parking issues.

Community Engagement

Further engagements to be arranged with PCSO.

Go Safe van to be arranged for traffic offence awareness and education.

More Police surgeries to be arranged with Councillors in Aber Valley area.

More engagement with schools to be arranged.

Neighbourhood alerts up and running and will continue to sign up members of the public in local areas.

Schools to be spoken to in regard to Operation Sceptre- Knife crime.

Members had no further comments.
